I refer to your official information request dated 27 August 2024 regarding the grazing of the land around the Council's reservoir in Pahiatua.

You requested information about the lease arrangements for the use of that land and asked why the lease was not advertised to the public.

The arrangements for the grazing of the land around the Council's oxidation ponds is part of the terms agreed to for the purchase of the land for the water treatment plant.

It is not a lease arrangement, therefore we are unable to supply you with information regarding a lease arrangement as such information does not exist. Therefore, your request for supply of that information is declined under section 17(e) of the Local Government Official Information and Meetings Act 1987.

You have the right to seek an investigation and review by the Ombudsman of this decision.
