I refer to your official information request dated 22 August 2024, seeking information about consent for a culvert that provides access to 56 Halls Road.

A stormwater assessment was provided as part of the application for consent. Tararua District Council required the stormwater assessment to be peer reviewed, and an engineer was engaged to undertake that review. The conditions of the subdivision consent relating to the vehicle crossing are:

 Prior to requesting approval under Section 224 of the Resource Management Act 1991, the vehicle crossing to Lot 1 must be upgraded in accordance with Council Standards for access to roads in the Rural Management Area as set out in Appendix 12 of the District Plan.

Note: A vehicle crossing application must be filled out and submitted with the appropriate fee to Council prior to the commencement of construction.

4. Prior to requesting approval under Section 224 of the Resource Management Act 1991, the double vehicle crossing to Lot 2 must be constructed in accordance with Council Standards for access to roads in the Rural Management Area as set out in Appendix 12 of the District Plan. The crossing shall include the installation of a 600mm diameter culvert beneath the crossing.

Note: A vehicle crossing application must be filled out and submitted with the appropriate fee to Council prior to the commencement of construction.
